North Port Events, owner of The Auckland Art Fair website take your right to privacy seriously. The Auckland Art Fair website is built to make it easy to find and share information with your friends, as well as connect with exhibitors and chefs before, during and after the show. This privacy policy deals with personally-identifiable information that may be collected by this website. This policy does not apply to other entities that are not owned or controlled by North Port Events. By using or accessing this site, you are accepting the practices described in this privacy policy.

### DATA GATHERING

For each visitor to our webpage, our web server automatically recognizes only the consumer's domain name, but not the e-mail address or payment information. When you enter The Auckland Art Fair website we collect your browser type and IP address. This information is gathered for all visitors. In addition, we store certain information from your browser using "cookies." A cookie is a piece of data stored on the user's computer tied to information about the user. These cookies terminate once the user closes the browser. We use cookies to store visitor preferences, record session information, such as what pages users access or visit, customize webpage content based on visitors' browser type or other information that the visitor sends.

You post content on the site at your own risk. Please be aware that no security measures are perfect or impenetrable. We cannot control the actions of other users with whom you may choose to share your pages and information. Therefore, we do not guarantee that content you post on the site will not be viewed by unauthorised persons. We are not responsible for circumvention of any privacy settings or security measures contained on the site. You understand and acknowledge that, even after removal, copies of content may remain viewable in cached and archived pages or if other users have copied or stored your content.

You are entitled to access any information which North Port Events may hold about you and North Port Events is obliged to provide this information to you as long as it has such information and such information can be readily retrieved. You are also entitled to request North Port Events to correct any inaccuracies in any information which North Port Events holds about you. North Port Events is entitled to charge you for the reasonable costs of retrieving, providing this information and as applicable correcting this information.

The Auckland Art Fair website also provides a platform for visitors to subscribe to third-party exhibitor newsletters, however this privacy policy does not cover any third-party newsletters. So we suggest you read exhibitor privacy policies on their own websites before signing up to their newsletters - information willingly provided to exhibitors through this website is out of North Port Events' control. North Port Events takes no responsibility for what exhibitors do with email addresses, data or information willingly provided to them by visitors on this site.

## **EXTERNAL WEBSITES**
